

## 1. Introduction

Danieli Corus B.V. and its subsidiaries (hereinafter: “Danieli Corus”) appreciate your interest in our products and services as well as the use of our website.

This privacy statement is meant to inform you on how and when we collect and process personal data, the types of personal data that we collect and process, how we use the information and with whom we share it.

## 2. Scope

This privacy statement is applicable when you contact Danieli Corus by e-mail, phone and/or through (forms on) the website. This statement also applies to the website itself.

## 4. Processing of your personal data

### 4.1 Customers

When you are contacting Danieli Corus as a customer, we may collect and process your contact information as well as any kind of personal data that you disclose towards us.

#### 4.1.1 Purpose of processing

The personal data will – if and insofar required – be used to set up and perform contracts between Danieli Corus and you(r organization) in the broadest sense of the word.

#### 4.1.2 Legal basis of processing

The legal basis of the processing is consent of the data subject, the performance of a contract and/or legitimate interests pursued by Danieli Corus.

#### 4.1.3 Data retention period

The processed personal data will be retained for the maximum duration of:

- 7 years after the contract was completely executed; or in case no contract is concluded
- 7 years after the (personal) data is received.

### 4.2 Suppliers

When you are contacting Danieli Corus as a supplier, we collect and process your contact information as well as any kind of personal data that you disclose towards us.

#### 4.2.1 Purpose of processing

The personal data will – if and insofar required – be used to set up and perform contracts between Danieli Corus and you(r organization) in the broadest sense of the word.

### **4.2.2 Legal basis of processing**

The legal basis of the processing is consent of the data subject, the performance of a contract and/or legitimate interests pursued by Danieli Corus.

### **4.2.3 Data retention period**

The collected personal data will be retained for the maximum duration of:

- 7 years after the moment the contract was completely executed; or in case no contract is concluded
- 7 years after the personal data is received.

## **4.3 Job applications**

When you apply for a job or file an open application, we may collect and process the following types of personal data:

### **4.3.1 Application form**

We collect and process the following personal data that you entered in the application form and/or included in the attachment(s) you have sent with the application form.

During the application procedure, additional personal data may be processed, including but not limited to minutes of (phone) conversations and your job interview as well as any kind of personal data that you disclose during the application procedure.

### **4.3.2 Purpose of processing**

The personal data will be used for the job application process. Only authorized employees, such as the department manager of the department to which the job vacancy relates and employees of the Human Resources Department of Danieli Corus, will have access to the above-mentioned personal data for evaluation purposes and – in case the job application procedure leads to a job at Danieli Corus – the onboarding process.

### **4.3.3 Legal basis of processing**

The legal basis of the processing is consent given by the data subject.

### **4.3.4 Data retention period**

The processed personal data will be retained for the duration of the job application procedure. If no employment contract is offered, we will delete the above-mentioned personal data after completion of the selection activities, unless you have given Danieli Corus explicit consent to store your personal data for the duration of maximum one (1) year after the job application procedure ended.

## **4.4 Ethics and Integrity Line**

When you click on the button of Ethics and Integrity Line, you will automatically leave the Danieli Corus website and be forwarded to the Ethics and Integrity Line of Danieli Group.

For the avoidance of doubt: this privacy statement does not apply to the Ethics and Integrity Line.

## 5. Transfer of personal data outside the European Economic Area (EEA)

Danieli Corus processes your personal data that you submitted to us through [info@danieli-corus.com](mailto:info@danieli-corus.com) and our website within the European Economic Area (EEA).

However, in case your inquiry relates to one of our subsidiaries outside the EEA or one of these subsidiaries is better able to help you, we may forward your inquiry (including any personal data it may contain) to the relevant subsidiary outside the EEA on a confidential, need-to-know basis.

For such international data transfers, we have put in place adequate measures, such as:

- A similar level of technical and organizational measures within our subsidiaries to ensure the protection of your personal data; and
- Contractual arrangements between our legal entities (for example for transfers from the EEA to countries not considered adequate by the European Commission, we have entered into EC Standard Contractual Clauses).

## 6. Security

We have implemented technical and organizational measures on the website as well as the backend of the website that ensure a level of security that is appropriate to the risk. These technical and organizational measures will be evaluated from time to time and adjusted if required.

However, please keep in mind that no method of processing personal data by automated means is 100% secure and we therefore cannot guarantee the absolute security of the website.

For Danieli Corus, the competent data protection authority is the Dutch Autoriteit Persoonsgegevens.
